WAIVER, ASSUMPTION OF RISK AND AGREEMENT TO HOLD HARMLESS

In consideration of and as inducement to the acceptance of my application for training by the PKC, I hereby agree to indemnify and hold harmless the PKC, it's volunteers, officers, members and agents from any and all claims, or claims by any member of my family or any other person accompanying me to any training session or function of the PKC, or while on the grounds or the surrounding area thereto as a result of any action by any dog, including my own.
